WHEREAS, The funds are to be used for the purpose of purchase of real property. Located at 121 S. Mulberry Street, Bremen, Ohio 43107, P/N 0350147700,.

WHEREAS, Rushcreek Township Board of Trustees agree to appropriate the funds from the General Fund, 1000-760-710-0000, 1000-110-730-0000 and 1000-110-510-0000 in the total amount of **\$65,000.00** . \$45,000.00 appropriated to 1000-760-710-0000 for the purchase price of the property, 1000-110-730-0000 for demolition and other associated expenses \$17,000.00, and 1000-510-300-0000 purchased services for closing and title fees \$3,000.00.

WHEREAS, Rushcreek Township Board of Trustees agree to appropriate funds from FIRE fund, 2191 To pay for expenses associated with repairs to MEDIC 541 in the amount of \$21,500.00.


